**AGREED ORDER MAKING COURT RECORDS
CONFIDENTIAL AND DIRECTING THAT CLERK
PUBLISH ORDER IN ACCORDANCE WITH RULE 2.420(e)(4)**

THIS CAUSE comes before the Court upon agreement of the parties and pursuant to Fla. R. Jud. Admin. 2.420(c)(9) and 2.420(e), and being fully advised, the Court finds as follows, in accordance with the provisions of Fla. R. Jud. Admin. 2.420(e)(3):

1. The above captioned case is a personal injury action.
2. This order is entered pursuant to Rule 2.420(c)(9).
3. All parties affirmatively agree to the entry of this Order.
4. The Court finds the importance in protecting the strong public policy favoring settlement agreements and recognizes that confidentiality of such agreements should not be regarded lightly. The policies in Florida protect the confidential interests of the present parties and non-parties at issue in compliance with the established public policy set forth in Florida, pursuant to Fla. R. Jud. Admin. Rule 2.420(c).
5. It has not been requested that any party's name be made confidential.
6. It has not been requested that the progress docket or similar records generated to document activity in the case be made confidential.
7. The following document, including its exhibits yet to be filed with the court shall be filed with the Clerk as confidential:
 - a. PLAINTIFFS' SECOND AMENDED MOTION FOR PARTIAL SUMMARY JUDGMENT AS TO DEFENDANT, MICHAEL W. RHODEN'S, FIRST, SECOND, THIRD, NINTH, TENTH, AND ELEVENTH AFFIRMATIVE DEFENSES TO SECOND AMENDED COMPLAINT, AND AS TO

DEFENDANT, MICHAEL W. RHODEN'S, LIABILITY UNDER COUNTS II AND VII.

8. The persons permitted to view the confidential records are: the parties, their counsel of record, and the Court.
9. The parties find that the decree, duration, and manner of confidentiality ordered herein is no broader than necessary to protect the interests set forth in Rule 2.420(c), and no less restrictive measures are available to protect the interests set forth in Rule 2.420(c).
10. The Clerk is directed to publish this Order in accordance with Rule 2.420(e)(4), which provides that within 10 days following entry of the Order, the Clerk must post a copy of the Order on the Clerk's website and in a prominent, public location in the courthouse, and the Order must remain posted in both locations for no less than 30 days.

Accordingly, it is

ORDERED and ADJUDGED that the Clerk and court staff shall maintain the confidentiality of the records described herein, and the Clerk shall publish this Order in accordance with Rule 2.420(e)(4). Any nonparty request that the Court vacate all or part of this Order must be made in strict compliance with the requirements and procedures of Rule 2.420(e)(5).
