Honorable Chairman Members of the County Commission Residents of Charlotte County

Pursuant to Section 218.35 Florida Statutes, presented herewith is the adopted fee officer budget for the Charlotte County Clerk of the Circuit Court for the 2017/2018 fiscal year. This statute requires the Clerk of the Circuit Court to prepare the budget in two parts: The budget necessary to perform Court Related functions as defined in F.S. 28.36 and the budget relating to the requirements of the Clerk as Clerk to the Board of County Commissioners, County Auditor, and custodian or treasurer of all County funds and other County related duties.

The Clerk's office revenues consist of charges for services and fees generated by the activities of the official records division, court related fines, fees and costs, interest earnings, miscellaneous charges and Board funding for those activities conducted on behalf of the BCC, as outlined in the June 1 budget submittal. Our request for Board funding has not changed from the June 1 submittal, and remains at a 1.9% overall decrease from the Fiscal Year 2017 amended budget.

The Records division fulfills the responsibilities outlined in Chapter 28.222 F.S which states "The Clerk of the circuit court shall be the recorder of all instruments that he or she may be required or authorized by law to record in the county where he or she is clerk." It also sets forth a fee schedule for service charges, which are used to support this function.

The 2013 Legislature made revisions to the court related funding of the clerk operations. The clerk retains court related fines fees and costs to perform the court related functions. Any excess monies collected are remitted to the Department of Revenue for deposit into the Clerks of the Court Trust Fund. The Florida Clerks of Court Operations Corporation (CCOC) oversees the budget process, granting budget authority to each of the 67 Counties based upon Florida Statutes budgetary guidelines for Court Operations budgets. Budget Authority was granted by the Florida CCOC on September 15, 2017. Charlotte County's Budget Authority for Court Related functions was reduced by \$111,454 or 2.9% from our original request.

The 2004 session of the Florida legislature established an additional \$4.00 per page recording fee to cover the cost of the Court Automation Systems (CAS). The CAS network is a centralized database and a central repository of images developed to meet the requirements of the agencies involved in the judicial process.

The information technology budget represents Helpdesk, Network, and Software Support activities performed by the Clerk's office in carrying out constitutional responsibilities and functions on behalf of the Board of County Commissioners.

At the direction of the Board of County Commissioners and in cooperation with its administration, a Records Center fund has been established to provide records management services to selected departments of the Board of County Commissioners. The Clerk acts as manager of this operation on behalf of the Board. The proposed budget represents the twenty-first year of operation.

The people of Charlotte County deserve effective and efficient service at the least possible cost. I believe this philosophy is reflected in this proposal.
