AGREED ORDER OF CONFIDENTIALITY

This cause having come before the Court on the agreement of the Parties to enter into an Order of Confidentiality for records to be Filed With The Court Under Seal, it is HEREBY ORDERED AND ADJUDGED that:

1. This is a civil case filed in the circuit court.
2. The parties agree that any and all Records to be relied upon by the Parties at the upcoming hearing on Plaintiff's Amended Motion for Attorney's Fees and Costs, currently scheduled for hearing on August 8, 2024, beginning at 1:30 p.m., will be filed Under Seal. Further, any documents referenced therein and attached thereto, including but not limited to:
 - a. Copies of all detailed invoices itemizing Wicker Smith's billing of attorney and paralegal's fees to BDH Contracting, LLC's insurance company;
 - b. The written fee agreements between BDH Contracting, LLC's insurance company and Wicker Smith Law Firm (Previously filed with the Court on July 16, 2024, as composite Exhibit "C" to Plaintiff's, BDH CONTRACTING, LLC, Notice of Filing Exhibits in Support of Amended Motion For Attorney Fees and Costs).
 - i. The confidential information within the Notice of Filing dated July 16, 2024 is precisely located at: **Page 14, Entire page, and Page 15, Entire page.**
 - c. Copies of all detailed invoices itemizing Bice Cole Law Firm, PL's billing of attorney and paralegal's fees to BDH Contracting, LLC's insurance company;

- d. Copies of all detailed invoices itemizing DGH Legal, PLLC's billing of attorney and paralegal's fees to BDH Contracting, LLC's insurance company; and
 - e. Copies of all detailed invoices itemizing Rolfes Henry Co., L.P.A.'s billing of attorney and paralegal's fees to Grange Mutual Casualty Company.
3. The Parties hereby represent that all materials listed in Paragraphs 2(a) through 2(e) herein have already been exchanged between the Parties in compliance with the Court's Remote Procedures Applicable to Evidentiary Hearings.
 4.  8. The Clerk of Court is directed to publish this Order in accordance with Rule 2.420(e)(4), Florida Rules of Judicial Administration.
